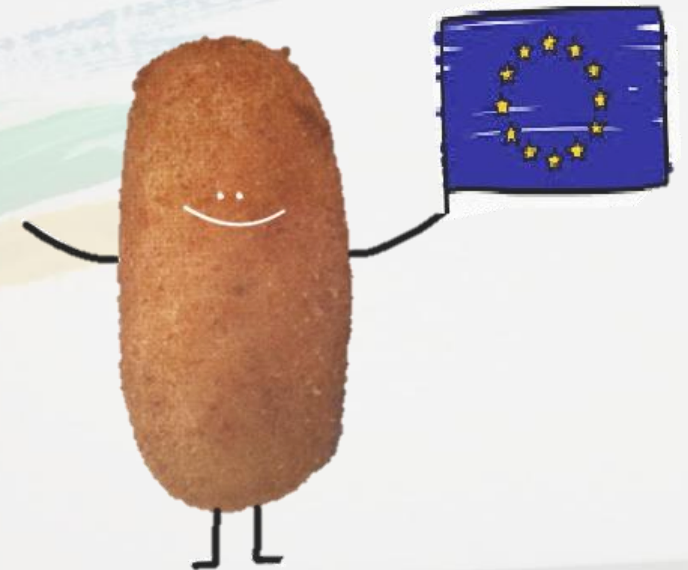

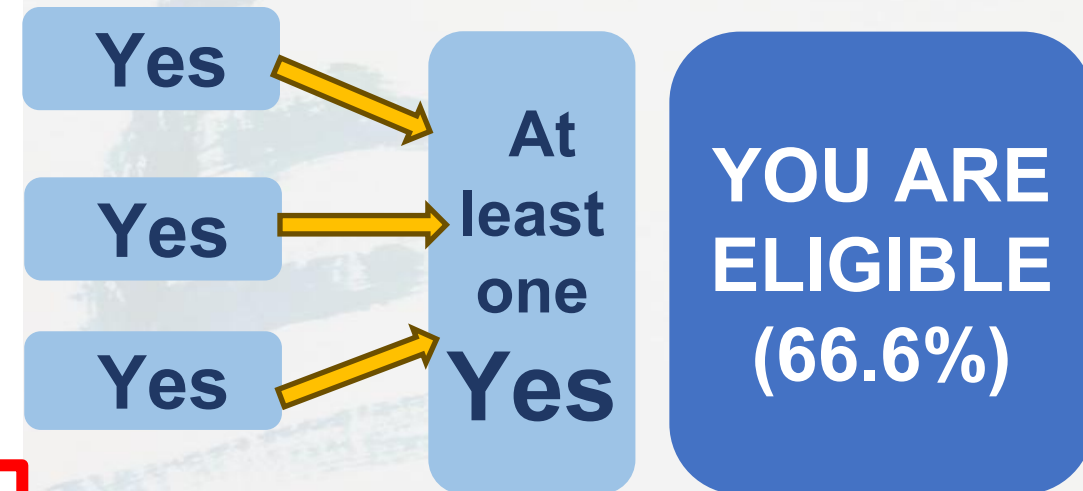

2.2) Specific eligibility criteria – qualifications

On the deadline for applications, you must demonstrate:

- (a) a level of education which corresponds to **completed university studies of at least three (3) years, attested by a diploma;**
- OR**
- (b) **completion of the Commission certification programme, based on article 45a of the Staff Regulations;**
- OR**
- (c) **attested vocational training of an equivalent level to university degree.**

Please note that **ONLY** diplomas that have been awarded in EU Member States² or that are the subject of equivalence certificates issued by the authorities of a Member State shall be taken into consideration.

ANNEX I

TYPICAL AD5 ADMINISTRATOR TASKS

AD5 administrators work independently in the interests of the service, to support decision-making in fulfilling the Commission's goals, in policy design, policy implementation and resource management.

The main tasks of AD5 administrators may include, for instance:

- conducting analysis;
- drafting reports and briefings;
- gathering, evaluating, and interpreting data for decision-making;
- contributing to the design, implementation, follow-up and control of initiatives, policies, projects, programmes or action plans;
- negotiating on behalf of and representing the Commission in different fora (e.g. interinstitutional, judicial, governmental, media, working groups, stakeholders' groups);
- drafting legal documents, including EU legislation;
- implementing, monitoring, enforcing and evaluating EU legislation;
- managing resources (e.g. budgetary/financial, human, informatics);
- performing communication, audit, or other activities.

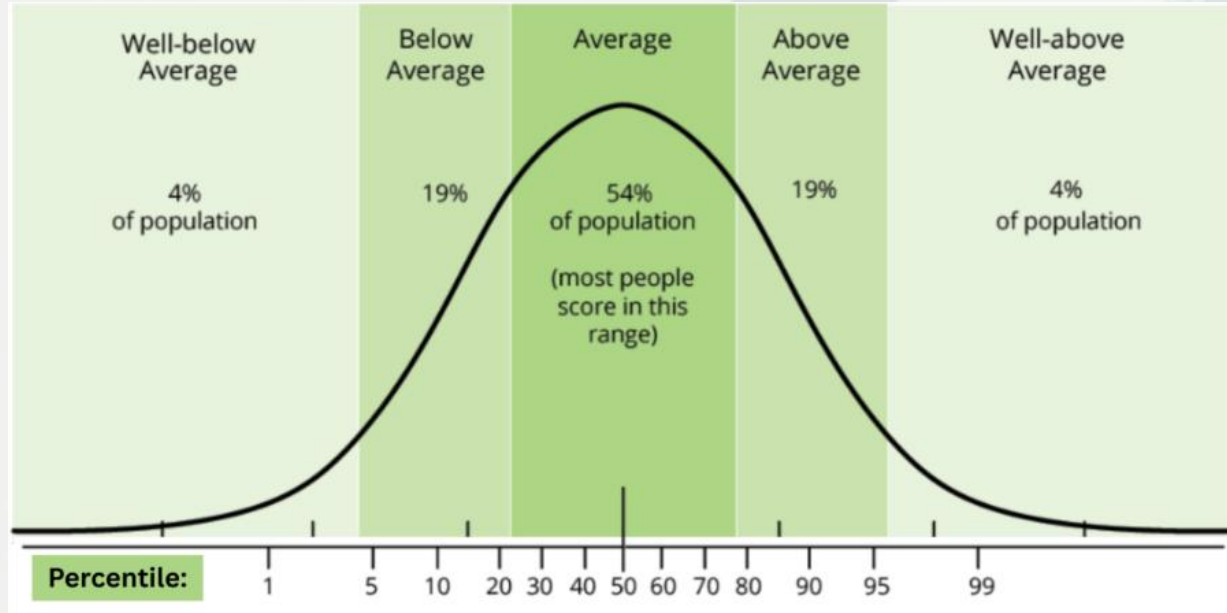

Eligibility conditions – cognitive reasoning

An external company, with recognised expertise in psychometric tests, is entrusted with the task to carry out the assessment. To measure the candidates' general cognitive ability, it assesses numerical, inductive, and deductive reasoning skills through 24 questions in 36 minutes



The company expresses the outcome of the assessment as a percentile of the relevant benchmark population (population of university graduates with several years of professional experience).

Candidates whose percentile rank is equal or higher than 60th percentile of the benchmark population will be eligible to take the tests of this competition as described from point 2) to 5) of Section IV of the notice of competition, subject to fulfilment of other eligibility criteria described in points 1 and 2.1) of Section II.

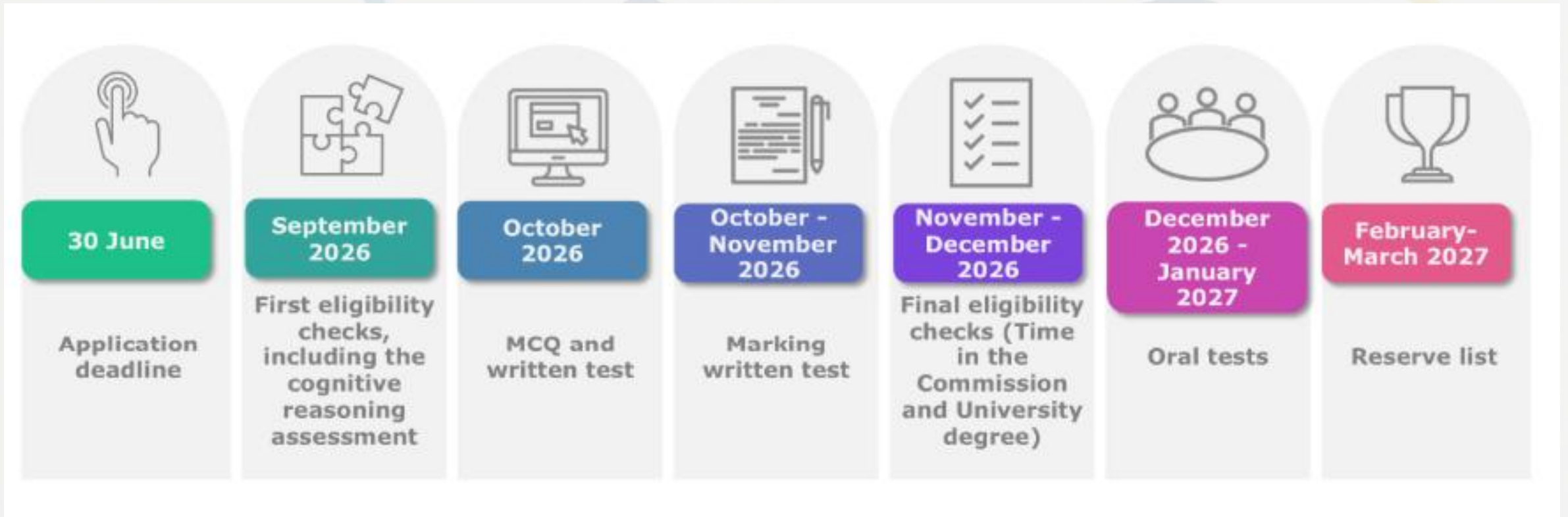

cognitive reasoning - numerical

Numerical Ability: The Numerical Ability questions are designed to measure the ability to solve problems involving numerical data by using the proper mathematical methods and the ability to interpret data presented in charts, graphs, and tables. Candidates will be asked to make correct decisions or inferences from numerical or statistical data. This ability is commonly required to support work and decision-making in many different types of jobs at many levels.

Numerical Ability Sample Question

A car dealership lowered all of its car prices by 15%.

Given the above information, what was the original price of a car now priced at £9500?

- A. £8075.00
- B. £10,925.00
- C. £11,000.00
- D. £11,176.47
- E. £12,322.13

To answer the question, the candidate must calculate the full price of the car before the 15% discount. The price £9500 is 85% of the full price (100%-15%). So, the calculation is the cost of the car post-discount divided by 85 (to find 1% of the full price), then multiplied by 100 to obtain the full cost pre-discount. So the answer is D: £11,176.47

Very similar to the EPSO numerical reasoning Reading the problem is key Despite the format

Example of Numerical – follow some conditions

- Sales for each employee per month. Each month is considered of 4 weeks.
- Online sales are distributed equally among the 10 employees
- If the employee sells more than 25% above the shop average per employee of the Quarter, all included, they get a 200€ bonus
- If the employee sells more than 50% above the shop average per employee of the quarter, all included, they get a 500€ bonus

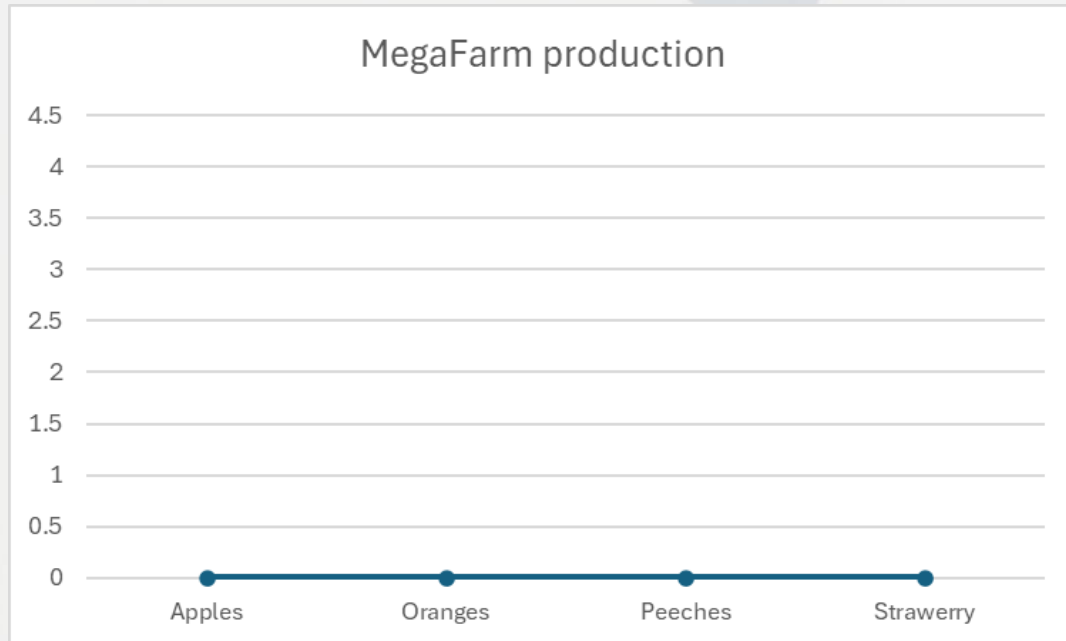

cognitive reasoning - Deductive

Deductive Reasoning: These questions are designed to assess the candidate's ability to draw logical conclusions based on information provided, identify strengths and weaknesses of arguments, and complete scenarios using incomplete information. It provides an indication of how an individual will perform when asked to develop solutions when presented with information and draw sound conclusions from data.

Deductive Reasoning Sample Question

Review the facts below.

- Jane drives a red car.
- Susan drives a blue car.
- There are no red cars in Ohio.
- Blue cars get 33 miles per gallon of gasoline.

Based on the information above, which of the following **MUST** be true?

1. Jane lives in Ohio.
2. Susan lives in Ohio.
3. Red cars get 36 miles per gallon of gasoline.
4. Susan's car gets 33 miles per gallon of gasoline.
5. Jane and Susan live in the same state.

The correct answer is D. Since blue cars get 33 miles per gallon of gas, the fact that Susan drives a blue car means that her car gets 33 miles per gallon of gas.

- Reading is key too.
- EPSO verbal reasoning can help you to practice but this one contains more details in less text
- Also exercises type dragging and dropping elements to construct your answer. [that imply close reading]

Example of Deductive

- A table with the calendar (hours or days) showing occupancy and free slots
- Not very time consuming
- Check the block slots on their content as they maybe linked to conditions
- Text will describe the conditions – get all info
- KEY to identify the minimal fulfilment condition [without or with it – it can / can't happen]

Remember - Schedule your task to end as soon as possible

Example of Deductive

- A calendar of 1 month (from 28 to 31 days)– Check day distribution – US calendar begins on Sunday
- Instructions may say “for the 30 Day calendar items, you may select up to 5 dates”
- Text will describe the conditions – get all info
- Conditions previous to the exam may indicate the working week is from Monday to Friday (general assumptions)
- KEY to identify the minimal fulfilment condition [cancel all dates when it can't happen]

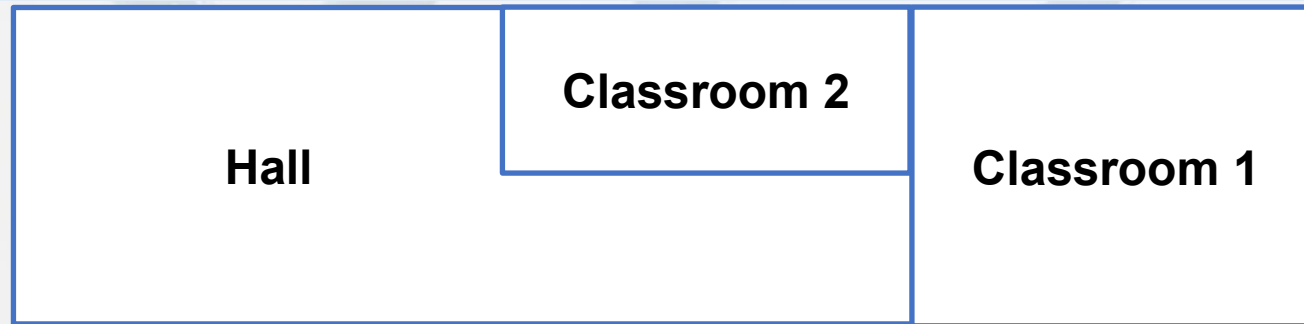

Example of Deductive

- A setting – rooms / resources
- 4 to 6 characters /objects
- Each item with its own conditions and/or the conditions introduction in the text
- Pay attention to the details – with that cover, solution should be fast.



Classroom 1 can't host science laboratory. Classroom 2 can't host History of art. Put each student in the corresponding classroom

Jaione will attend history of arts and philosophy

Amaia must be in the same class as Patxi

Igor can't be in same class as Amaia

Patxi must attend his mathematic course

Uxue will attend literature and History

Markel needs to attend science lab



cognitive reasoning - inductive

Inductive Reasoning: Ten questions are completely non-verbal and feature only shapes and figures. These questions are designed to measure the ability to detect regularities, patterns, and generalizations and infer rules that can be applied to different situations. Individuals high in this ability tend to excel in global and strategic thinking and are good at finding errors in work processes.

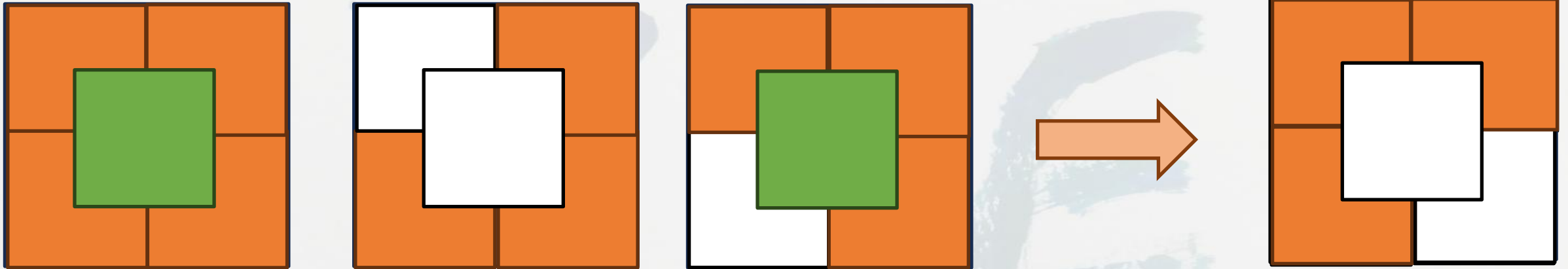

The correct answer is C. Each row contains 1 of 5 different shapes in no particular order. The only shape missing in the 4th row is a triangle and the only shape missing in the 5th row is a circle.

Same mechanics as the abstract reasoning by EPSO
Patterns may be very different + linking elements, following a logic

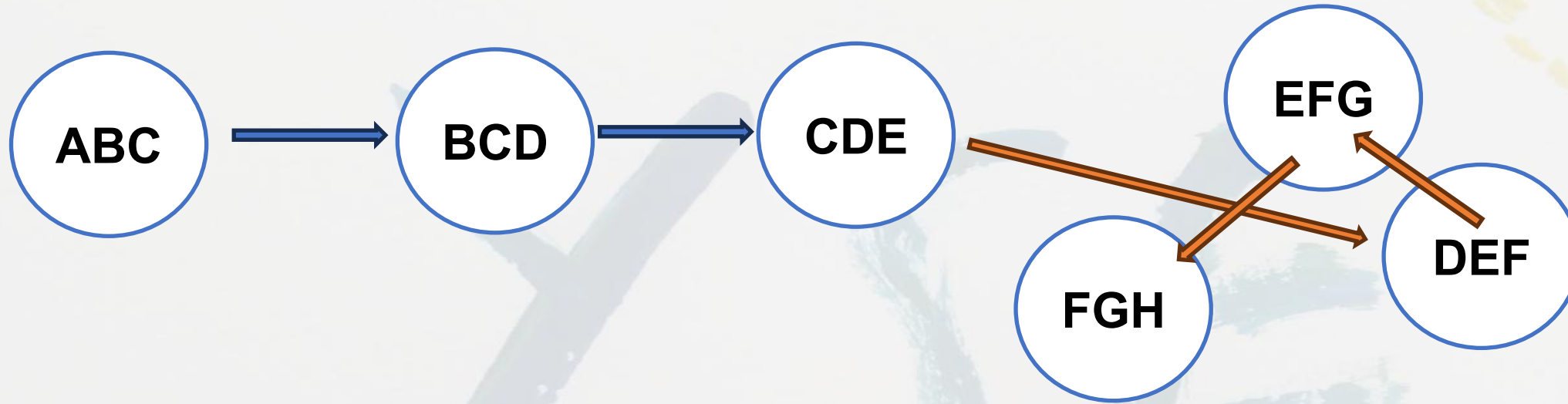
Example of Inductive



Shapes to fill in a specific colour (3 variables – colour 1, colour 2, blank)

- Shapes can be of any type
- Number of references can vary (3 to 5)
- Logics (very similar to EPSO)
 - Movement / displacement
 - Overlap
 - Numbers
 - Symmetries
 - Alternatives

Example of Inductive



- Follow the logic type
- 2 to 5 items inside the circle : letter, numbers or signs . Alone or combined
- 2 to 4 circles to catch the logic

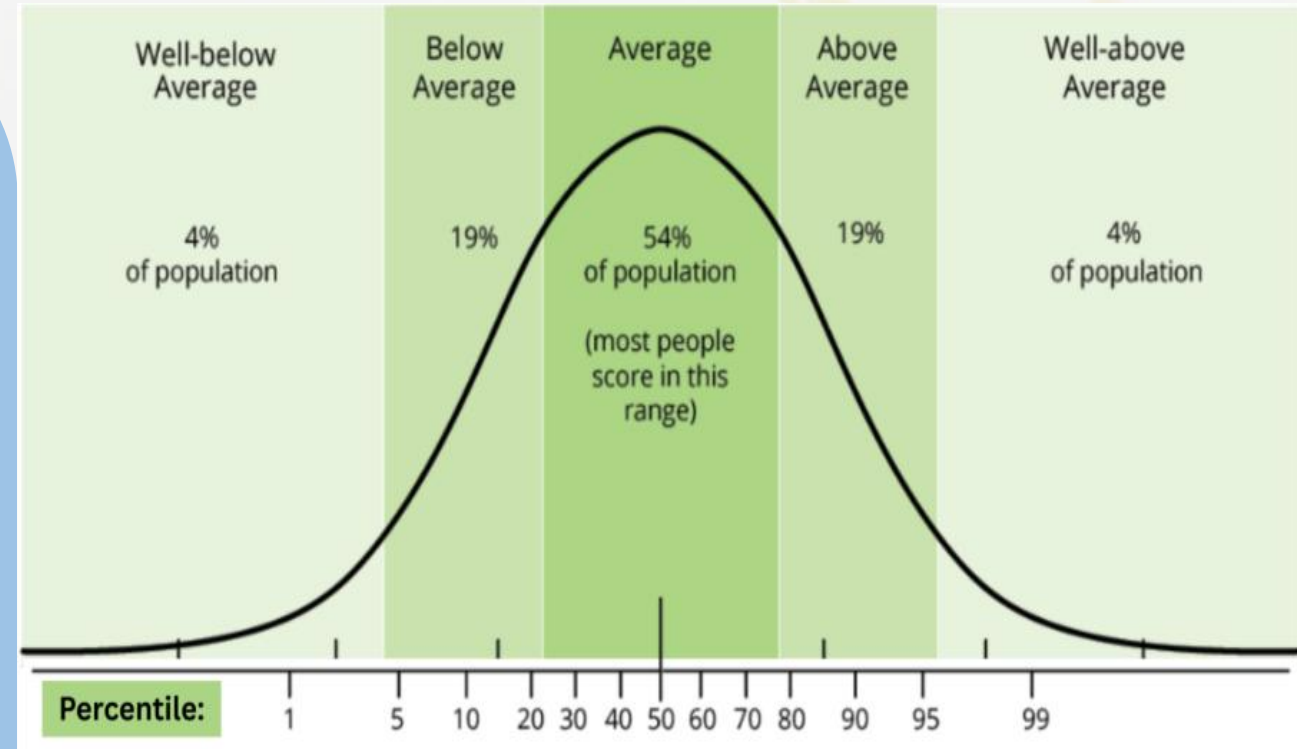
Logics:

- Adding / subtracting
- Letters movement (letters can have a numerical value)
- Instructions



cognitive reasoning – conclusions (after Ad7)

- Check SHL for further examples [free access]
- Physical paper and calculator will be allowed during the exam
- The exam is easier than it may seem at first
- Wrong questions doesn't take you points
- Better to finish all 36 questions
- Good Practice (quality not quantity) will help you for:
 - Accurate answers
 - Fit in the time (36 is tight but not impossible)

The MCQ test consists of 30 questions designed to assess candidates' EU knowledge. Candidates will be tested on their knowledge of EU institutional setup, the Commission's roles and powers under the EU treaties, the Commission's governance, decision-making and procedures, as well as the Commission's policy priorities. Guidance for preparation and a sample of questions will be shared on the competition's dedicated page on Staff Centre prior to the date of the test.

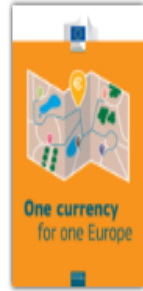

- Critical thinking, analysing & creative problem-solving;
- Written communication.

Your **written test will be assessed** only if you

- obtain the required pass score in the computer-based multiple-choice question ('MCQ') test **and**
- obtain one of the highest scores in the MCQ test, up to a maximum of **2.5 times** the number of successful candidates sought in this competition.

The computer-based multiple-choice question ('MCQ') test on EU knowledge, and the written test will take place online, on the same day. The instructions and information relating to the conduct of the tests will be set out in the invitation.

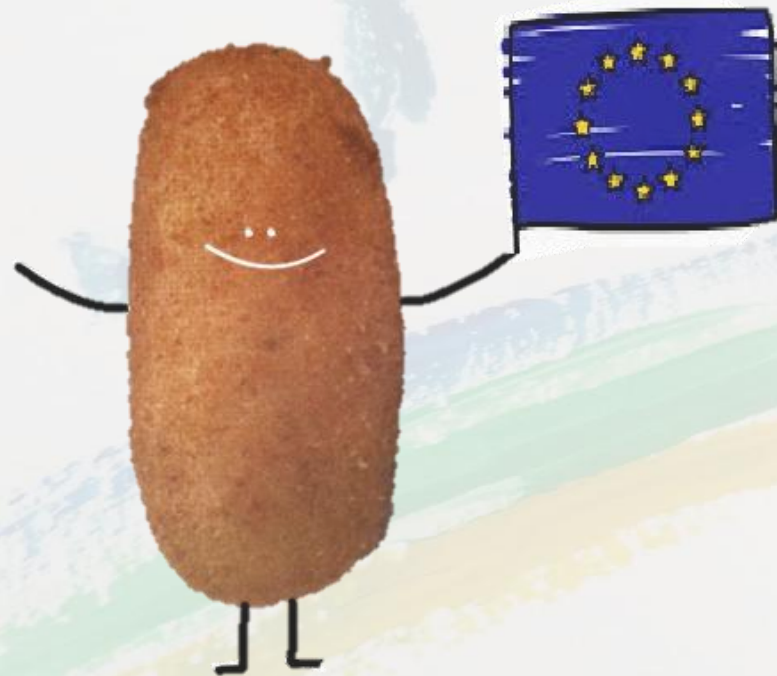
